## SECTION 2 – HAZARDS IDENTIFICATION

## SECTION 4 – FIRST AID MEASURES

**SKIN:** Remove contaminated clothing. Rinse skin with water for at least 15 minutes/shower.

Consult a physician if irritation persists.

<b>EYES:</b>	Rinse immediately and cautiously with water for 15-20 minutes, keeping eyelids open. Remove contact lenses, if present and easy to do. Continue rinsing. Call a physician immediately.
<b>INGESTION:</b>	Rinse mouth. Do not induce vomiting. Drink 3 to 4 glasses of water. Do not give anything by mouth if victim is unconscious. Call a physician immediately.
<b>INHALATION:</b>	Breathe fresh air. Give artificial respiration if necessary. Consult a physician if discomforts persist.
<b>MOST IMPORTANT SYMPTOMS AND EFFECTS, BOTH ACUTE AND DELAYED:</b>	Skin: Burning and severe skin damage, redness of the skin. Eyes: Causes serious eye damage. Symptoms may include burning, tingling, watery eyes, redness, swelling and blurred vision. This could result in permanent eye damage.

## SECTION 5 – FIRE-FIGHTING MEASURES

<b>EXTINGUISHING MEDIA:</b>	Water spray, carbon dioxide, chemical powder, foam.
